### AGREEMENT, RELEASE AND WAIVER OF LIABILITY

1. I will abide by the rules, regulations, policies and programs of **MOLLY'S MUTTS AND MEOWS**, a California nonprofit corporation (MM&M) while I am a volunteer.
2. If I stop being a volunteer for MM&M for any reason, or upon MM&M's request at any time, I shall promptly return all of MM&M's property.
3. I recognize that while performing tasks, including handling dogs and cats, for MM&M, there exists a risk of injury as well as risk of personal property loss or damage. I assume the risk of all injuries or property damage in connection with my volunteer work for MM&M.

**For and in consideration** of permitting the above named person to participate as a volunteer for MM&M, I hereby voluntarily agree on behalf of myself, my heirs, personal representatives, or executors, to release, discharge, indemnify and hold harmless MM&M, its agents, servants and employees from any and all claims, causes of action or demands, of any nature or cause connected with my acting as a **VOLUNTEER** for MM&M. This might include court costs and attorney's fees incurred by MM&M in connection with my **VOLUNTEER** services based on damages which may be incurred or sustained by me in any way. Such damages and injuries may include, but are not limited to, dog or cat bites, claw scratches, allergic reactions and other injuries or illness and excited or inadvertent canine and feline accidents to me or my clothing and other personal property damage. In connection with this release, I expressly waive the provisions of the California Civil Code, Section 1542 which provides as follows:

**A general release does not extend to claims which the creditor does not know or suspect to have exist in his or her favor at the time of executing the release, which if known to him or her must have materially affected his settlement with the debtor.**

By my signature, I indicate that I understand that this release is intended to discharge in advance MM&M, any of its officers, agents or employees for any of the above-mentioned causes of action, even though that liability may arise out of negligence or carelessness on the part of MM&M or its personal. In addition, my signature grants MM&M authority to treat any minor Volunteer for injuries that occurred while at MM&M. MM&M will not be liable for the costs associated with any treatment.
